Please note, CFI-West **ACCEPTED** the challenge to duplicate Meier's "easily duplicated hoax" UFO photos. They have failed. **AFTER MORE THAN THREE YEARS THEY HAVE FAILED.** And they have publicly **REFUSED** to have their photos tested in accordance with the same scientific standards as Meier's were.

Do you have **ANY** ethically based reason why this should not first be resolved, as well as proclaimed loudly from the rooftops? These people, Randi included, have been slandering Meier and now they have been shot down. This will not go away.

As for Randi, he of the enormously diminished credibility. **HE CLAIMED** that the Meier case/evidence was a hoax. He based that claim (we have the correspondence) on the photographic evidence. Now he has **RETRACTED** that claim. Seems pretty clear that if he retracts the claim, as he just has, he is now saying that the case is **NOT** a hoax. Unless of course you **THINK** he's saying that he retracts the claim that the case is a hoax...but that means that he's saying that the case is still a hoax. If so, take it up with him.

If the case is not a hoax it is paranormal by definition. After all, this pack of party magicians and illusionists who specialize, indeed make their livings, on **CREATING** and **EXPLAINING** illusions, and who have thereby designated themselves the arbiters of reality with sufficient confidence to put up a \$1,000,000 reward for proof of the paranormal, **SHOULD** be able to show "how this was done". That's what they **DO**, they "debunk", i.e. "**SHOW** that something is wrong or false".

Randi's not in charge of this show anymore. Therefore, he is not in the position to start a new challenge. If he has **ANY** integrity he will first **DEMAND** that CFI-West either have their photos tested by **APRIL 15** (the date I set for the fulfillment of **MY** predictions, and **MY** claim on the \$1,000,000) or that they pay up and issue a public apology. And you can all knock yourselves out trying to "debunk" and **DUPLICATE** it. Why are you waiting for a man of dubious abilities (Randi can't debunk/explain/duplicate UFO photos made by a one-armed man **30 YEARS AGO**) and dubious character (he won't demand fulfillment of the challenge by his associates, payment for failing to do so and offer payment for his own retraction of the challenge and failure to meet it)?

If you, or any of the rest of the "scientists" who are trying to wiggle out of this, have anything further - of interest - to say, I'm sure you won't hesitate to do so. In the meantime, the **CLOCK IS TICKING, APRIL 15 LOOMS ON THE HORIZON**.

And, isn't it curious that Skeptic magazine hasn't held Randi and CFI-West's feet to the fire on this? They couldn't be, how shall I say this, **NON-OBJECTIVE SHILLS and TACIT CO-CONSPIRATORS IN THIS ATTEMPT TO DEFRAUD MR. MEIER and CONCEAL THIS FROM THE PUBLIC**, could they?

Application for \$1,000,000 Award from

I, Michael Horn, known to countless millions everywhere as the unwavering (t)horn-in-the-side of pseudo-scientists, poseurs, charlatans and frauds everywhere, do hereby make the following predictions and submit them as proof of my paranormal abilities. In so doing, I am applying for all financial awards offered by the James Randi Foundation, CFI-West and any and all other affiliated or non-affiliated individuals, groups and organizations offering such awards for proof of paranormal abilities:

1. **I PREDICT** that CFI-West will not submit their photographs, that attempt to duplicate Mr. Billy Meier's UFO photos, to the same known, specified, rigorous, scientific standards and protocols Mr. Meier's were.
2. **I PREDICT** that James Randi will not demand that CFI-West have their pictures thusly tested in order to fulfill the challenge that CFI-West accepted (February 2001), i.e. to duplicate Mr. Meier's "easily duplicated hoaxes", as any objective, principled scientist would emphatically demand.
3. **I PREDICT** that James Randi and CFI-West will continue to attempt to shift the focus of the original challenge away from CFI-West's failure to meet the challenge.
4. **I PREDICT** that these predictions will be fulfilled up to and including April 15, 2004, a very taxing day in itself.

The odds against these predictions being fulfilled is actually astronomical since no professional, reputable, credible, scientific,

honest and genuinely objective entities would ever allow, encourage or promote such dishonest, slimy and despicable conduct, (i.e. avoidance of fulfillment of the terms, and misdirection and obfuscation, of the challenge they accepted), as a means to avoid meeting its obligations to pay these awards to any parties who have demonstrated paranormal evidence or abilities.
