Hi Tim,

Nice to meet you. I appreciate the background info as well. I'm especially interested in your background as a private investigator, since this case has elements concerning evidence and motive that would surely be closely examined if this was a criminal case, for instance.

I wish to go to your comment about evidence of alien visits, since it's obviously a genuine consideration if one is to be logical and not expect people to "believe" the case is true without it. Let's also acknowledge, or please present some rational reason to reject, that the ETs, should they exist, would be a bit more intelligent than we are. That being the case, we must incorporate into our examination of evidence as much thinking and reasoning as we can, especially in light of the actual information allegedly given by them to Meier that pertains to their agenda and method of operation.

This brings us back to the points, regarding evidence, that I have firmly maintained regarding the photographs. Let's review, again in light of your own comment about evidence, some of the following, which may be unknown to you since it hasn't come up in our discussion and your interest has been primarily, and now understandably, on the metals.

The investigators, led by Lt. Col. Wendelle Stevens (USAF, Ret.), spent some six years investigating the case. Their own team had telecommunication and electronics experts as well as photographic experts. They had access to the top labs, personnel and equipment. They ascertained that Meier had taken around 1,200 clear, daytime photos of up to four craft at a time, some in sequence shots (where the ships change their relationship to each other as well as to the environment), eight 8mm movie films, one video, sound recordings done on a cassette machine (40 minutes) outdoors, in front of 15 witnesses including an undercover policeman, and of course the metal alloy samples. In addition, there are over 100 witnesses to the UFOs as well as at least four other photographers.

Nice as all the physical evidence may be, there is an even higher standard of proof and this is what I have gathered and researched over the years. The Contact Reports are the transcripts (single-handedly typed by Meier himself) of his conversations with the Plejaren, mainly from 1975 on but with some excerpts from as early as 1956. I acquired the first roughly translated English version of some 1800 pages in 1986. They had been available for at least a few years prior to my getting them.

So as to not make this interminably long, suffice it to say that I found numerous items scattered throughout, of a very specific nature, that proved to be prophetically accurate, i.e. were published before "official" discovery or the occurrence of the events foretold. The time in advance varied from a few weeks to years, even decades, later. My article "Proof Beyond A Reasonable Doubt" categorizes a lot of this information. I must note that we have the documents and books in question, as I mentioned, I am on record some time ago as having acquired my copy in 1986, and the books bear copyrights and ISBN numbers.

In the course of my research I culled dozens of these specific items, which were often told to Meier in the course of conversation, while some info was actually presented within the context of prophecy. I did extensive internet searches, and let's remember that there was no such thing during the time this information was published by Meier. I looked to see if the information was accurate, if so when the event or discovery occurred and when it was first known or published. In all cases that I researched, I found that the event/discovery occurred, i.e. that the info was accurate, and the first knowledge of it conformed to its publication, or dated record, by Meier.

Considering the accuracy regarding the wide scope of topics (again, see my article), and the possibility of it being known by Meier through any other means than those he asserts, I could only come to the conclusion that, amazing as it may seem, he was truthful regarding his claims of ET contact. Again, we have copyrighted documents and books, the publication dates of which precede the actual occurrence or discovery of specific events by substantial time periods. Please understand the significance of this.

Now let's visit your area of interest, the metals, for a moment, and start with the somewhat glossed over fact that Marcel Vogel, whose speciality was the conversion of

energy inside crystals, and who had a fairly good understanding of a number of related matters, examined (using scanning electron microscope) metal alloy samples presented by Meier. He found that they contained nearly every element in the periodic table, including the rare earth element thulium, which I don't have to tell you is more expensive than platinum. His analysis revealed a number of unusual characteristics under increased magnification and he reasonably concluded that the technology necessary to assemble this sample exceeded any available to him - or to the metallurgists who also viewed it - as a scientist at IBM.

Now, while you might say that Marcel Vogel wasn't "expert enough" do you think that he was party to a hoax or duped by a farmer playing at metallurgy? When you look at the photo analysis and the sound analysis and then include the eyewitness reports, the other known photographers and, to me most importantly, the prophetically accurate information, do you not see a preponderance of the best "circumstantial" evidence you've ever encountered? Add to your consideration the known facts that all of this was produced within a three or four year period (including the physical evidence) by a one-armed man with no known or ever discovered accomplices, technological or financial support. While engaged in his alleged contacts he also worked to renovate a substantially sized, rundown property to make it fit for living for his wife, three children and some friends...while he was attracting the attention of some 19 individuals who would attempt to murder him (a lot of trouble to take to get rid of a hoaxer).

Now, while we're not done with the metal issue yet, please understand why your abrupt dismissal, in your earlier correspondence, of anything other than the metals was not going to be accepted or acceded to. We can't simply demand that evidence be produced how,

when and where we want it. If only that was so, then police forces, and investigators such as yourself, would be spending more time on vacation in the Bahamas and less doing the hard grunt work required in reality.

At this point let me introduce my other premise, that the entire case is less about ETs and UFOs than it is about our future survival, a conclusion I base on the following reasoning.

The information, starting with specifics presented to Meier in 1956 (some 48 years ago) has proven to be prophetically, impeccably accurate. With such an unprecedented track record of accuracy, the information that pertains to these and future times bears careful consideration. This information, for these times, also extends back many, many decades and includes very current info as well.

In the simplest sense, we are being warned that, unless there are some specified course corrections made very soon, we will march down an irreversible path that leads to the loss of 2/3 of humanity and the destruction of the northern hemisphere. Quite a number of unpleasant specifics are provided. Now, one can answer that any number of parties have "predicted" similar things and that it doesn't take an ET or a Swiss farmer to either agree or disagree with the information. This also reflects the inability of people to grasp the context of the case and its evidence and, paradoxically, reinforces the long-standing condition of non-violation of people's free will in regards to being forced to recognize the reality of the case. I dare say that most people, perhaps with the unfortunate exception of the destruction-craving radical Islamic terrorists, can't quite grasp the magnitude (let alone the reality) of what is being said here.

So, regarding the metals, which you may have noticed that I never said that I was in

possession of, and which you probably presumed based on an attempt by the skeptics to distract from and conceal (as magicians like to do) the boring, mundane facts surrounding their being completely baffled and trounced by the photographic challenge, samples are said to still be in the possession of Meier.

I personally perceive problems with testing them, even if a hundred of them were put on the table right now. Apart from simple chain of command problems and the like, let's consider that, while another scientist or ten might also conclude that they had something inexplicable in their hands, I'll bet none of them would, or could, come out and say that they could prove that it was extraterrestrial. This would only actually further obfuscate the "real" issues and the skeptics would be left off the hook, let me explain why.

The situation the skeptics find themselves in right now is one in which they are faced, by their own admission (Randi) and failures (CFI-West) with evidence of the "paranormal", which is at the heart of the challenge to them since they maintain (to the collective tune of \$1,005,000 US) that no such thing as paranormal exists. Further, because prominent among them are magicians and illusionists, whose very specialty is creating and detecting illusion, hoax and fraud, their absolutely abysmal failures and now ethical and financial dilemmas, show forth so loudly and clearly that awareness of the case, and its now further substantiated reality, is increasing worldwide, witness our communication.

This is a situation that I am not going to allow to be diffused or distracted from, whether there may be further testing of the metals, because, frankly, I think the skeptics would love to see such testing precisely because of the "inconclusive" conclusions that could be drawn concerning even still irreproducible metal alloys.

Now, while I am very open to that discussion, I'll reiterate that the predicament

the skeptics are in, which has even caused them to publish a pathetic disclaimer (which I've, of course, rebutted) is one that has enormous importance and will either, eventually, result in their dissolution as a group with any integrity, credibility or ethics, or possibly give birth to an honest (and extremely well respected, genuine and **WARMLY WELCOMED**) acknowledgment that they have actually learned something new and that there is, indeed, in the Meier case something quite worthy of honest, objective scientific examination.

In other words, if the egos and vested interests of these parties can be surmounted from within, if they regain a sense of humility in the face of the unknown (rather than act like the church in its confrontation with Galileo) then there's no reason why all parties couldn't examine and struggle through this with the same honest intention: to find out what is true and what the meaning of the entire matter is. Certainly, any and all perceived hostility and baiting of them by me and others would vanish in a second, it's obviously (to anyone who thinks this through) not my intention to engage in these battles, which, nonetheless have served to bring this to the attention of literally millions of people worldwide. Please don't misunderstand, while I'm a reluctant warrior, much preferring cooperation and discovery to conflict, I have no hesitation in vigorously engaging my friends currently opposed, nor to using the proceedings to increase awareness of the case, important as I perceive it to be to mankind.

I learned that my previous attempts at open, friendly communication with Randi, among others, were perceived as weakness, unfamiliar as they appear to be with the steel hand within the velvet glove.

So, if the "loyal opposition" is inextricably bound, and compelled, to enact the role of "dark background upon which to shine the light of truth" then so be it. If there's a willingness to overcome misplaced pride, ego, etc. - a challenge with which I have much personal familiarity, with varying results - I would stand at the head of the line in welcoming it, again NOT for personal gain, gloat or glorification, rather

to cooperatively get on with the work at hand as it relates to the welfare of all humanity.

I am keeping your personal comments/information out of this correspondence since I am sharing it with various parties pro and con. I welcome your, and others', comments including those regarding the metals. Nonetheless, you know my previously stated priorities as well as my, hopefully now clearly understood, preferred and higher purpose, which includes the cooperation of ALL parties (and the mutual suspension of all attacks, criticisms, derision, etc.) in the pursuit of truth and benefit to all mankind.

Now I've calmed down a bit, let me tell you who I am. I would have thought that you would welcome the chance to prove the sceptic community wrong.
